Minutes of the Full Parish Council Meeting of Amcotts Parish Council held in Hook House Farm offices, Amcotts on 11th March at 7:30pm

The Full council meeting began at 7:30pm

- 1. Declarations of Interest:** Cllr Barker Pi windfarm matters
- 2. Approval of minutes of meeting of Full Parish Council on 22/01/15 – Resolved** to accept as a true record with the amendment of Cllr P Murphy in attendance.
- 3. Matters arising:** Village survey now completed 49 in support of the church feasibility study and the alternative broad band solution and 2 against a total of 51 respondents
- 4. Accounts:** Clerk advised that the current bank balance is £976.30 before we receive the Parish precept. Accounts resolved for payment were. Arrow £288 delivery £30. Clerks Wages and expenses x 3 months £120 total, PAYE£30, RNS Accts £180.
- 5. Parish Insurance:** It was noted that the addition of the Parish Clock to the policy would be needed once repairs had been effected. A bid for NLC Community Pot needs completion by the clerk for consideration after the elections.
- 6. SSE Microfund:** Clerk confirmed that she has requested the payment of £1500 for Amcotts Parish to be used for small projects where they would be ineligible to apply to the other fund.
- 7. Planning:** No applications to consider however a document from SSE Keadby Windfarm was discussed which requests consideration of a scoping and impact assessment should they infill the existing area with up to 21 additional wind generators.
