The view of Amcotts Parish Council is for prior approval to be **refused** on the basis of "the design and external appearance of the building and any impacts on the location and siting of the building(s)" should be explored in a full planning application, given that other planning applications (and appeals) have been refused for similar properties in this immediate vicinity.  
Concern was also raised regarding surface water drainage from the site to a nearby dyke and the Trentside road itself is liable to surface flooding after periods of heavy rain.


