Applications for Consideration:

- a. **PA/2017/1682** Planning permission to site a metal storage container for a
temporary period of 2 years at Millennium Gardens, corner of Church Street and
Chapel Street, Amcotts:

During the 20 minute public participation time, concerns over the siting of the
container were raised. Both members of the public attending called for complete
removal of the storage container. A petition containing 12 signatures was received
asking for removal.

Resolved to accept the offer from St Marks Community Group to clad the
container in wooden cladding (subject to planning approval) and await the
decision of NLC Planning when the consultation period ends on 4th January 2018.

Resolved that should planning permission be refused, the container would be
removed and a revised application be submitted to site the container in the back
corner of the garden away from from the roadside (the current location of the
bench seating), with wooden cladding to soften the appearance.

- b. PA/2017/1977 Planning permission for the construction of a Flood Defence Scheme comprising of sheet piling along the right bank of the River Trent; the placing of scour protection along the right bank of the River Trent; localised property protection within a managed overflow area at land to the north of the M180 Bridge; the raising of existing earth embankments and flood walls; and associated construction works.
