91/17 North Lincolnshire in Bloom: Grant of £250 received from North Lincolnshire Council for flower bulbs in Amcotts.

**Resolved** to accept Mr G.Jackson offer to organise the purchase and planting of the bulbs, and in addition is to develop a wider planting scheme for Amcotts. Location of bulbs/flowers: Entrance/exit to village (both village and parish boundaries); the Millennium Garden; riverbank benches; and the bus shelter.

**Resolved** to add St Marks Church into the Emergency Plan as a safe refuge that can provide a warm and dry shelter with kitchen and toilet facilities.

94/17 Public Footpath #6 Consultation: North Lincolnshire Council are consulting on the route of Footpath #6 (running between Trentside and St Mark's Church) - specifically the exact route at The White House, Trentside.

**Resolved** to recommend to the Public Rights of Way Officer at NLC that Footpath #6 should dead end at the Bank House/Salisbury House boundary due to lack of use by the community (no through access to Trentside is required) and the security concerns of accessing residents properties (either Salisbury House or White House).
