## 040/2022 Footpath between Amcotts and Luddington

With regard to footpath 5 between Amcotts and Luddington. At the present time, the grass verge is not being maintained along this footpath and Luddington Parish Council are requesting an agreement with themselves and Amcotts Parish Council to add this grass verge to Luddingtons contract to maintain and Amcotts Parish Council to reimburse them with the cost to cutting the section in Amcotts Parish. As NLC fund grass cutting along all footpaths that are on the footpath map, it was suggested that Luddington Parish Council contact NLC to add footpath 5 to the map and so obtain funding before giving a contract to cut it. As there is no grass on the verges of Amcotts part of footpath 5, Amcotts Parish Council do not need to pay towards any maintenance cost. Luddington Parish Council will contact NLC to investigate the matter and advise Amcotts PC of the outcome.

#### 041/2022 Planning

The following are the main observations Amcotts Parish Council have regarding the changes to the project KS3 Keadby Development:

Concerns over height of stacks.

There is currently light pollution with the existing plant which will be made worse following the changes.

Potential disruption to traffic through Keadby.

The PC will make these observations known to the applicant.

Green Energy Park planning process has been delayed again because the Company are not giving consideration to environmental issues.

St Marks Community Group have registered local woodland and have an environmental interest which will need to be considered as part of Green Energy Park plan.

## 044/2022 Updates from Outside Bodies

## St Marks Church

The Public Notice period for the fitting of the porch doors will end on the 20<sup>th</sup> of March. If no complaints are made to the Chancellor by this time, the doors will be fitted. When the porch doors have been fitted, work on getting the vestry roof repaired and painted can begin. The rainwater from the roof will be harvested and used to water the butterfly garden. A grant from SSE was awarded to do these works.

The vicar is on sabbatical for 3 months. A baptism is to take place during this time.

## St Marks Community Group

The RHS has been in touch with St Marks Community Group and informed them that they should go forward to the final 6 in the country in RHS competition. The national finals are in July and there will be 4 medals. St Marks Community Group have been advised by SSE to send in a written bid for a grant to help with the cost of the competition. Work is now underway to obtain quotes for supplies needed.

# NLC Ward Councillor Updates
