There will be a Halloween event in the church on the 31<sup>st</sup> of October. The books have been audited and there is a balance of £1.51.

## NCL Ward Update

Have just completed the Fuelled HAF programme. Lots of children attended including those on free school meals. It was a very successful programme to which over 45 providers contributed a range of activities.

Free swimming was also very successful. The council is refocusing on swimming and education as there has been accidents involving water.

Alvingham Road, the replacement respite centre for disabled children and their families, will be completed in June 2023.

Wellspring College will have a soft opening in March and a full opening in September 2023. It will take 60 students. The focus will be on getting education and employment.

There is to be a national social care review. North Lincs Council is to be in the review. Took away lots of ideas and put them in. This is a once in a generation in childrens social care. Community events can help children and give them a sense of citizenship.

The national bus review has been done. There has been a significant change in travel patterns with there being more leisure travel than work travel. The local network is stable and not losing any bus routes.

There is a high number of Ukranian families in North Lincolnshire and government guidance is awaited on what will happen next. The question is being asked of these families as to whether they feel part of the community.

North Lincs Council is funding for Next Generation to buy St Oswalds Church Hall. It is with the solicitors at the moment and will be bought and developed into a community resource for all ages to use. Cllr Murphy attended the open day and saw the different ideas of activities and services. There will be 8 people on the committee. This will be a good base for people from Keadby and Amcotts.

PC to contact NLC to take FP5 off the contract as this does not have grass to cut.

## 138/2022 North Lincolnshire Green Energy park

There was a meeting with the group, now named RAIN, a couple of weeks ago where the Planning Inspectorate invited people to attend. There was nothing agreed at this meeting but at a subsequent meeting the report seemed better for Amcotts Parish Council. Amcotts Parish Council can support RAIN response but also need to register as an interested party. This has to be done by 15<sup>th</sup> of September. PC to complete the form online to register an interest on behalf of Amcotts Parish Council. The objections will be:

- Noise Pollution
- · Lack of need due to over capacity
- Threat to recycling
- · Adverse effect on air pollution
- Odour pollution

A number of residents distributed a flyer to show what could happen if an incinerator was built. Residents from Keady and Skippingdale also saw the flyer and it seems Skippingdale residents were unaware of it.

# 139/2022 Village Signs
