NLC Councillor Update

NLC held a Cabinet meeting on Monday. £25 million to BSIP funding for buses, for which £2.3 million is for infrastructure for digital bus signs.

As the winter fuel allowance has been removed, NLC aim to bridge the gap by awarding £200 to people who miss out on this allowance.

To help with costs, anyone in North Lincolnshire of pensionable age can apply for an air fryer or slow cooker from NLC. Applications can be made online or at the Community Hub. The nearest one to Amcotts is Crowle Hub.

NLC are to launch the Green Badge Scheme. It is similar to the Blue Badge Scheme. It is not for the long term disabled but is a temporary measure for people who need it for example after an operation. It can be used in NLC car parks and supermarkets across the area. It cannot be used on roads.

Bus 360/361 have super Saturday between now and Christmas for £1 fare every Saturday. Just Go bus service can pick up after being booked for £1 per journey.

NLC are supplying free trees for planting between now and March. NLC will plant them.

Isle North Neighbourhood Act Team (NAT)

The meeting was held recently. The Police are reporting that general crime is better. For the winter period, they have changed their priorities to include wildlife crime. There have been several thefts from tradesmen vans whilst at work in houses.
